

2019 ENTRY FORM REQUIREMENTS FOR YOUNG ACHIEVER CATEGORY

Entry for the 2019 New Zealand Building Industry Awards is an online process. Individual and team entrants can nominate themselves. Visit nzbuildingindustryawards.org.nz/register/ for information on entry eligibility and costs.

Below outlines what is required to complete the entry forms. We suggest you collate your responses, then copy and paste into the entry form. The entry form can be saved and continued later using a provided link.

KEY NOMINEE AND NOMINATOR INFORMATION

Please note: If you have an administrator in your team who will manage your entry, and any other logistics relating to the Awards, please include their details.

- Up to 4 x high-resolution photos of the Nominee (file size limit 5MB)

ABOUT THE NOMINEE

- In 500 words or less, tell us about the Nominee. The Nominee's background may include details on any of the following:
 - Current employment details
 - Previous roles and experience
 - Progression of the Nominee's career to date
 - Key project or role responsibilities that the Nominee has been presented with
 - Qualifications and affiliations
 - Previous Awards and achievements (both industry and non-industry related)
- In 500 words or less, tell us why the Nominee is considered a high achiever at this early stage of their career:
 - Provide details of recent significant achievements where the Nominee has made an important contribution or had substantial influence.
 - Explain specifically how the Nominee contributed to (or was responsible for) those achievements.
 - Skills and value that the Nominee has brought to the organisation they work in/have worked in.
 - What has been the most challenging project or role that the Nominee has undertaken to date, and how did they overcome those challenges.
 - Other challenges that the Nominee has been presented with during their career to date.
- In 500 words or less, the Nominee should reflect on their career to date, and outline their vision for their future. The Nominee's background may include details on any of the following:
 - A brief description of your career goals and how you plan to achieve them? e.g. Are these career goals realistic and do they express goals that will benefit the profession and industry rather than just you?
 - What steps have you undertaken to develop yourself as a future industry leader?
 - Are you further ahead in your career than you would have expected to be at the age you are?
 - Does the career you have had so far reflect the goals that you originally set yourself?
 - How do you feel you have contributed to the built environment and how do you intend to continue doing so? Provide short examples to support your statements (bullet points accepted).
 - Have you undertaken any activities with professional bodies?
 - Have you undertaken any research work that may have contributed to the initiative to encourage new or more efficient ways of doing things, within your company or on your projects?
